The fact that a visa has been granted to me does not mean that I will be entitled to compensation if I fail to comply with the relevant provisions of article 5.1 of the Schengen Implementing Convention and am refused entry. The prerequisites for entry will be checked again on entry into the territory of the Schengen states.
