I am aware that any false statements will lead to my application being rejected or to the annulment of a visa already granted, and may also render me liable to prosecution under Polish law.</p> <p>If a visa is granted, I undertake to leave the territory of the Schengen states not later than the last day of the visa's validity.</p> <p>I am aware that possession of a visa is only one of the prerequisites for entry into the territory of the Schengen states. The fact that a visa has been granted to me does not mean that I will be entitled to compensation if I fail to comply with the relevant provisions of article 5.1 of the Schengen Implementing Convention and am refused entry. The prerequisites for entry will be checked again on entry into the territory of the Schengen states.</p>
